On January 9, 2012, the Department filed an Administrative Complaint against Ms. Burke alleging violations of: Sections 468.217(1)(x) and 468.223(1)(e), Florida Statutes, stating Ms. Burke was employed at Halcyon Rehabilitation at Royal Manor and practiced occupational therapy at the facility with a suspended license from May 28, 2010 to March 19, 2011.

- 468.217 Denial of or refusal to renew license; suspension and revocation of license and other disciplinary measures.
  - o (1) The following acts constitute grounds for denial of a license or disciplinary action, as specified in s. 456.072(2):
  - (x) Violating any provision of this chapter or chapter 456, or any rules adopted pursuant thereto.
- 468.223 Prohibitions; penalties.
  - (1) A person may not:
  - (e) Use or attempt to use a license which has been suspended, revoked, or placed on inactive or delinquent status;

**MOTION:** Ms. Watson made a motion to accept the Terms of the Settlement Agreement which Includes:

- Payment of \$1500 fine and costs of \$859 to be paid within 365 days as of the date of filing the Final Order, and a
- Reprimand by the Board.

Mr. Spafford seconded the motion which carried 5/0.

# MOTION OF DETERMINATION OF WAIVER AND ENTRY OF FINAL ORDER FOLLOWING HEARING

TAB 2 Krishna C. Mohr, file# 3263, OTA 10392, Case # 2011-21031 (PCP – Johnson, Mullings)

Krishna C. Mohr, was not present and was not represented by counsel. Mr. Phillip Mullings was recused for having served on the probable cause panel.

Ms. Sykes summarized the case for the Board.

On July 9, 2012, an Administrative Complaint was filed by the Department alleging violations of: Sections 468.217(1)(h) and 468.217(1)(x), Florida Statutes, stating Ms. Mohr failed to provide proof of completion of 26 hours of continuing education completed during the March 1, 2009, through February 28, 2011, licensure biennium, as required for her licensure renewal.

- 468.217 Denial of or refusal to renew license; suspension and revocation of license and other disciplinary measures.
  - (1) The following acts constitute grounds for denial of a license or disciplinary action, as specified in s. 456.072(2):
  - o (h) Failing to perform any statutory or legal obligation placed upon a licensed occupational therapist or occupational therapy assistant.
- 468.217 Denial of or refusal to renew license; suspension and revocation of license and other disciplinary measures.

- (1) The following acts constitute grounds for denial of a license or disciplinary action, as specified in s. 456.072(2):
  - o (x) Violating any provision of this chapter or chapter 456, or any rules adopted pursuant thereto.

**MOTION:** Ms. Watson made a motion that Ms. Mohr was properly served and waived her right to a formal hearing. Mr. Hicks seconded the motion and the motion carried 5/0.

**MOTION:** Mr. Hicks made a motion that the material facts, as alleged in the Administrative Complaint, are not in dispute, and adopted the allegations of fact in the Administrative Complaint, as the Board's conclusions of fact in this proceeding. Ms. Watson seconded the motion which carried 5/0.

**MOTION:** Mr. Hicks made a motion that the Board adopt the allegations of law in the Administrative Complaint, as the Board's conclusions of law in this proceeding. Ms. Watson seconded the motion which carried. 5/0.

**MOTION**: Mr. Hicks made a motion that the Board adopt the materials under Tab 2 and any addendum materials into evidence in this proceeding. Ms. Watson seconded the motion which carried 5/0.

**MOTION:** Ms. Watson made a motion to impose the following penalties:

- A Letter of Concern to be issued against Ms. Mohr's license.
- \$100 fine payable within 90 days of the filing of the final order.
- \$507.10 in costs payable within 90 days of the filing of the final order.
- Completion of the outstanding 26 hours of continuing education within 90 days of the filing of the final order.

Mr. Hicks seconded the motion which carried 5/0.

# TAB 3 Jennifer Lynn Tergliafera, OTA 10188, Case # 2013-02666 (PCP – Johnson, Mullings)

Ms. Tergliafera was not present and was not represented by counsel. Mr. Phillip Mullings was recused for having served on the probable cause panel.

Ms. Sykes summarized the case for the Board.

On December 19, 2012, Ms. Tergliafera was dismissed from the Physician's Recovery Network (PRN) program for noncompliance. The Department issued a Uniform Consumer Complaint against Ms. Tergliafera alleging that she violated Sections 468.217(1)(t)(x) and 456.072(1)(hh), Florida Statutes.

- 468.217 Denial of or refusal to renew license; suspension and revocation of license and other disciplinary measures.
  - (1) The following acts constitute grounds for denial of a license or disciplinary action, as specified in s. 456.072(2):
  - (t) Being unable to practice occupational therapy with reasonable skill and safety to patients by reason of illness or use of alcohol, drugs, narcotics, chemicals, or any other type of material or as a result of any mental or physical condition. In enforcing this paragraph, the department shall have, upon probable cause, authority to compel an occupational therapist or occupational therapy assistant to submit to a mental or physical examination by physicians designated by the department. The failure of an occupational therapist or

occupational therapy assistant to submit to such examination, when so directed, constitutes an admission of the allegations against him or her, upon which a default and final order may be entered without the taking of testimony or presentation of evidence, unless the failure was due to circumstances beyond his or her control. An occupational therapist or occupational therapy assistant affected under this paragraph shall, at reasonable intervals, be afforded an opportunity to demonstrate that he or she can resume the competent practice of occupational therapy with reasonable skill and safety to patients. In any proceeding under this paragraph, neither the record of proceedings nor the orders entered by the board shall be used against an occupational therapist or occupational therapy assistant in any other proceeding.

- (x) Violating any provision of this chapter or chapter 456, or any rules adopted pursuant thereto.
- 456.072 Grounds for discipline; penalties; enforcement.
  - (1) The following acts shall constitute grounds for which the disciplinary actions specified in subsection (2) may be taken:
  - (hh) Being terminated from a treatment program for impaired practitioners, which is
    overseen by an impaired practitioner consultant as described in s. <u>456.076</u>, for failure to
    comply, without good cause, with the terms of the monitoring or treatment contract entered
    into by the licensee, or for not successfully completing any drug treatment or alcohol
    treatment program.

Ms. Tergliafera chose to voluntarily relinquish her license as an Occupational Therapy Assistant in lieu of undergoing further disciplinary proceedings in this matter and agreed to never reapply for licensure as an Occupational Therapist Assistant in the State of Florida.

# TAB 13 CE@ Renewal Update

The Department of Health, Division of Medical Quality Assurance (MQA), will now review continuing education records in the electronic tracking system at the time of renewal. Ms. Garnet Nevels briefly addressed the Board to advise re: CE@Renewal, the integration of the DOH renewal system and CE Broker. It will happen automatically when a licensee renews a license. Reporting of continuing education will be optional for OT/OTA's for the 2015 renewal, however will become mandatory for the 2017 biennium renewal

Discussion: Rule Change Proposal from Bureau of Enforcement

- 64B11-4.006 Mediation
- 64B11-4.005 Citations

The Bureau of Enforcement requested the Board to amend the following rules to allow resolution of additional violations by mediation and citation. These changes are proposed to increase mediation authority for minor violations, thus eliminating costs of service, investigation, prosecution, and compliance for successful mediation, as well as change citation authority for second time violations or instances where meditation is unsuccessful. In addition, with the upcoming CE@Renewal changes this allows mediation for continuing education violations, until continuing education is required to be documented for renewal, and eliminates the citation rules regarding continuing education.

The Board briefly reviewed and tabled this discussion until the July 2013 meeting as Ms. Amie Rice, with the Bureau of Enforcement, was unable to attend the meeting. Board Counsel was asked to bring back proposals regarding the types of violations which may be moved under the mediation rule.

The Board was addressed by Mr. Larry Gonzalez, representing a CE provider, not the Florida OT Association (FOTA). Mr. Gonzalez submitted a proposed Rule amendment to Rule 64B11-5.001(11)(a)(1) to allow a continuing education lecturer or author to receive continuing education credit for their Laws and Rules and Medical Errors courses they present for more than just the initial presentation, as stated in the current Rule language. The Board discussed and agreed to amend the Rule to allow continuing education lecturers or authors to receive continuing education credit for their Laws and Rules and Medical Errors courses they present 'for each biennium' as opposed to only receiving credit for a first time presentation.

After discussion, the Board requested Board Counsel to prepare draft language for Rule 64B11-5.001(11)(a)1 for the July 2013 meeting, as recommended and discussed.

# 64B11-5.001, F.A.C., Requirements for License Renewal of an Active License; Continuing Education & 64B11-6.001, F.A.C., Continuing Education Program Approval; Dynamic Learning Correspondence re: Online Interactive Education

The Board directed Board Counsel to draft language with consideration of the items below.

- Eliminate home study. Categorize credits under "Non-interactive" and "Interactive" ref. paragraph (3). Interactive is to be defined as requiring "real-time" interaction with the course presenter/author during the time the licensee is participating in the course.
- "Interactive" designation pertains only to courses, not to providers, as providers may offer some courses which do not necessarily meet the proposed definition.
- Modify (11)(a) to provide the semester hour continuing education credit equivalency for presenters of academic courses to 1 credit per semester hour up to the maximum of 8 per biennium defined in (11).
- Modify (11)(b) with ref. to PT Rule 64B17-9.001(6)(d), F.A.C.
